### **Meeting Minutes**

# Treasurer's Report

Lisa Gantner: The general fund balance has not changed since our last meeting and remains at \$2004.53.

# **Borough Social Media Metrics**

Gabriel Hirsch: With the completion of our renewed tennis/pickleball courts, I wanted to help get the word out to
residents and locals that they were available for play. Two Facebook posts went up, a first to highlight that it was
open, with a before and after picture for comparison. The second post included a more in-depth blog style article
that described the benefits of the renewed courts to our community, and a little information about pickleball.

Together, these posts have accumulated almost 15,000 individual views, with a peak of 50x our average daily page views on September 17<sup>th</sup> and 21<sup>st</sup>. This is good precedent for future utilization of social media to showcase renewal projects in the borough, to residents in and around Sinking Spring.

# **Old Business**

# Signs Committee Research Findings

• Lura Bare: The signs committee spoke with 3 electronic sign vendors since our last meeting. Average prices, based on the examples discussed in the last signs committee meeting, are around \$30,000 and up. Many of the electronic signage in our area come from Horst Signs.

We (Lura and April, Signs Committee) also took a look at the existing signs in the borough, which are in rough shape. We reached out to the installer of the signs, and they said they are not in good enough condition to revitalize.

# **Discussion: Signs Committee Research Findings**

- Bob Metzger: The existing sign ordinance needs to be changed to accommodate this electronic signage project, or a variance needs to be used.
- Lisa Gantner: The sign in front of Wilson is nice and toned down, we want to avoid looking like we are in Vegas.
- Gabriel Hirsch: Other aspects of the project we have considered are the ability for local businesses to put their
  advertisements on the sign, in exchange for a sponsorship fee. This project could also be expanded beyond the
  signage, for example parklets or recreational areas to spruce up the intersection.
- Laura Mursch: One possible funding route could be a main street program. Pocket parks could be funded through DCNR grants. I would reach out to Derek Harris regarding the LSA grant, he has a lot of experience with those.

# PennDOT TASA Application Status

• Gabriel Hirsch: My recent meeting with PennDOT TASA and RATS MPO officials occurred on October 6<sup>th</sup>. In that meeting, I received feedback on our application regarding the Broad St. ditch cleanout and pedestrian bridge project. This feedback should help ensure the final submission is complete and gets the best chance of approval. Final submission date for TASA application is October 31.
